## Information on Law School Applicants, Applications, Admissions, and Matriculations by Virginia Tech Students and Alumni/ae

This handout provides information on how many Virginia Tech students and alumni/ae have applied to law schools over the past ten years, how many have been accepted by one or more law schools, where Virginia Tech degree holders have enrolled in law school, and related data. This summary and the accompanying tables are based on annual reports provided by the Law School Admission Council (LSAC) to the University Pre-Law Advisors at Virginia Tech. This summary is based primarily on reports covering applications during the 2014-2015 academic year, for admission to law schools beginning in the fall of 2015. Information on applicants, applications, and acceptances during the 2015-2016 academic year is expected to be available in 2017.

Please keep in mind when reviewing this information that standards for admission to law schools vary, both across schools and from year to year. In addition, admission rates are based on where individuals choose to apply, not only on applicants' credentials. If one seeks admission to one or more law schools, it is important to apply to an appropriate range.

During the academic year 2014-2015, approximately 81% of Virginia Tech students and alumni/ae who had taken the Law School Admission Test (LSAT) but who had not previously enrolled in law school applied to one or more law schools. During that academic year, 70 Virginia Tech seniors and 86 Virginia Tech alumni/ae *applied* to a total of 170 law schools. Of these 156 Virginia Tech degree holders, 131 (84.0%) were *admitted* to 129 different law schools within 42 states and the District of Columbia. (64 of the seniors, or 91.4%, were admitted to one or more law schools.) Of the 131 Virginia Tech degree holders admitted to one or more law schools during the 2014-2015 academic year, 114 (58 seniors) *matriculated* in the fall of 2015 at 58 different law schools within 25 states and the District of Columbia. The average grade point average (GPA) of those who applied to law school from Virginia Tech during the 2014-2015 academic year was 3.27; and the average highest score on the Law School Admission Test (LSAT) for those applying to law schools that year was 154.8.

Table 1 summarizes some of these data, along with comparable data from prior years. In addition, table 2 shows the first majors of those from Virginia Tech who disclosed this information.

The Pre-Law Advisors have complete lists of the law schools to which Virginia Tech students and alumni/ae applied, where they were admitted, and where they matriculated during the past ten years. Briefly, during the academic year 2014-2015, Virginia Tech degree holders were admitted to all eight of the accredited law schools in Virginia, and in the fall of 2015 enrolled in all eight of them: Appalachian School of Law, George Mason University School of Law, Liberty University School of Law, Regent University School of Law, University of Richmond School of Law, University of Virginia School of Law, Washington and Lee University School of Law, and William and Mary Law School. Virginia Tech degree holders were admitted to four law schools in Washington, D.C., and enrolled in all four of them: American University Washington College of Law, Catholic University of America – Columbus School of Law, George Washington University Law School, and Georgetown University Law Center. In the fall of 2015, Virginia Tech degree holders also enrolled in law school at: Arizona State University – Sandra Day O'Connor College of Law, Atlanta's John Marshall Law School, Barry University – Dwayne O.
